

## Christopher Deegan Obtains Dismissal of Case Against Elevator Service Company

Obtained dismissal of a case against an elevator service company where the plaintiff alleged that she slipped on wet stairs because an elevator was out of service; successfully argued that no duty of care was owed to the plaintiff and that there was an intervening and superseding cause of the plaintiff's injuries
